- \$150 per application plus certified mail notification.

- \$300 per application plus certified mail notification.

- \$300 per application plus certified mail notification.

- LCHIP (\$25 Payable to The Strafford County Registry of Deeds.)

- LCHIP (\$25 Payable to The Strafford County Registry of Deeds.)

- \$150 per application

- \$150.00 Application Fee; Per variance request
- \$250.00 Public Notice Fee

B. Special Exceptions:

- \$150.00 Application Fee; Per variance request
- \$250.00 Public Notice Fee
- \$10.00 per abutter-including owner and all professionals

C. Appeal from Administrative Decisions

- \$150.00 Application Fee; Per variance request

D. Equitable Waiver of Dimensional Requirements
